

## **SLL SUES SEN. JOHN BRIGGS**

Senator John Briggs (R-Fullerton), author of the defeated Proposition 6 anti-gay initiative, failed to show up at California State University, Fullerton on Oct. 26 to debate Rev. Eric Garris.

A lawsuit for \$3,500 was filed by attorney David Bergland on Oct. 31 in the Fullerton Municipal Court for "breach of contract." Senator Briggs and the California Defend Our Children were served as defendants. Plaintiffs also include the Orange County Committee Against Senator John Briggs



Libertarian Society (SLS), directed by Milton Mueller and the fourth plaintiff, Rev. Eric Garris.





at Santa Ana College in lecture room W101.





#### SLL LEADER ASSAULTED

Lawrence Samuels, Chair of SLL since 1973 and chief organizer of the Briggs vs Garris debate, was physically assaulted by Kathy Bailey (Briggs' daughter) and Mrs. Briggs several days after the lawsuit against Briggs was announced. The assault occurred in Garden Grove after a debate between Briggs and the late Harvey Milk of San Francisco.

Attorney David Bergland informed Samuels that a charge of battery could be filed against both Briggs' daughter and wife. No battery suit has been filed yet against the Briggs family.

#### KEN GREGG GIVES LEC. ON 19th CENTURY LIBERTARIANS

Kenneth Gregg, Jr., considered as one of the best libertarian historians on the West coast, will give a lecture at Cypress College on Fri., Feb. 23 at 7:30 pm in room L-216 (Library Lecture Hall).


Gregg attended both Cal State Long Beach and Long Beach City College as a history major. He studied at Rampart College, Nathaniel Branden Institute and the Free Enterprise Institute. Other independent studies include Standford University, UCLA and Workingman's Institute at New Harmony, Indiana (site of the Robert Owen community and the early experiments in anarchism by Josiah Warren).

Involved deeply in Science-Fiction (editor of SFALBulletin), Gregg is co-director with George Smith of the Los Angeles Libertarian Seminars. He is currently writing a biography of Thomas Hodgskin, considered as the first free market anarchist.

Some of the individuals that Gregg will center on will be Thomas Hodgeskin, Charles Conte, Lysander Spooner, Charles Dunoyer, Josiah Warren and Benjamin Tucker. He will also touch on the Agrarian Movement of the 1840's.

The speech is free of charge.

Prof. Devon Showley, a member of SLL's Advisory Board, will introduce Gregg. The lecture is sponsored by the Cypress Libertarian Club & Society for Libertarian Life.



Libertarian lawyer, John Joseph Matonis, drew a crowd of 100 at Santa Ana College on Nov. 3...SLL at Cypress College and The Cypress Philosophy Club sponsored Dr. Madsen Pirie from Hillsdale College. The lecture was entitled "Marx is dead. Von Hayek lives." Around 90 students attended. The speech also sparked articles in the campus newspaper. One hostile article said that "libertarians are self-centered egotistical anarchists who love nothing but themselves." The author then said that this was absurd because, "besides themselves, libertarians love their revolvers, automobiles and, yes of course, their police dogs." Anyone for a lawsuit... SLL showed the film "LIBRA" to several civics classes at Sunny Hills High School in Fullerton, CA... Howard Hinman showed LIBRA at California State University, Fullerton twice...Dave Lynch and Ray Irvine have been added to the SLL Executive Board at large...An ad for SLL appeared in the Riverside City College campus paper, but SLL did not place the ad. Interestingly enough, a fairly libertarian article by Viewpoint Associate Editor Mary McMackin appeared above the ad. Probably just a coincidence...Jane McLaughlin, manager of Morningrise Printing and Bob McGinley, president of Wide World of Contemporary People, have joined SLL's Advisory Board... Alan Heath, former vice-chair of SLL, heads the Association Of Voluntarists (AOV). ## "A TIME FOR TRUTH" BESTSELLER BY W. SIMON

According to James M. Buchanan in *Reason* magazine, William Simon's new book, *A Time for Truth*, "is well argued, well supported, and well received."

William Simon held high position in the Nixon and

William Simon held high position in the Nixon and Ford administration. He is best known as the nation's first energy "czar" during the oil crisis of 1973-74.

Libertarians will find *A Time for Truth* very entertaining. In the first place, it show a politician, William Simon, discovering that government causes or enlarges most social and economic problems facing the nation today. Simon learns this from firsthand experience. One example brough out from Simon deals with energy controls. Simon discovered that controls did not work, except to increase the bureaucracy and produce further controls. Simon, in essence, blames Nixon and Ford for extending further controls over oil and gas through monumental mistakes in their administrative policies.

Perhaps Simon's is at his best when comparing New York City as a microcosm of the nation. In Simon's analysis, according to James Buchanan, "New York behaved for many years as if it had sources of money, using obligations that were not credit-worthy in any sense and essentially defrauding its creditors by the jiggling of accounts and of the promises of politicians."

A Time for Truth has been on the bestseller list for months and is worth reading. It is conservative-libertarian arguement for individual liberty and a semi-free market. Simon is well-aware of radical libertarian approaches to economics. Perhaps in good time, Simon will progress further along the libertarian line. (New York: Reader's Digest Press, McGraw-Hill Book Co. 1978, 248 pp., \$12.50.)

#### ARREST AT MORNINGRISE

The saga of Morningrise Printing in Costa Mesa, California continues. Jane McLaughlin, manager of Morningrise Printing, was arrested Friday, Sept. 29 by two police officers. The dispute is over a \$10 business license.

Two newspapers (The Register and The Daily Pilot) in Orange County gave Morningrise Printing's plight front page coverage. The Register included a front page photo of Ms. McLaughlin calling her a "hard line libertarian businesswoman."

McLaughlin was cited a few months ago for operating a business without a business license. She refused to fill out the business license forms because it would automatically waive her rights to her own property. One of the questions McLaughlin refused to answer was how much money she makes. She said that it is none of the city's business how much money she makes.

After being released from jail on a \$100 bail, she sued the judge for damages amounting to 1,500 grams of gold (around \$11,000). Judge Donald Dungan is being sued for depriving McLaughlin of what she termed a "procedurally fair trial."

She plans to represent herself in court and has demanded a trial with a jury of her peers--all non- registered voters like her. Morningrise Printing is also getting some legal advice from libertarian lawyer John Joseph Matoric

Joseph Matonis, J.D.
Since many libertarian groups patronize Morningrise Printing, one of SLL's leaders was present at McLaughlin's arrest. One of the arresting officers threatened everyone in the print shop with arrest if they interfered, even though no one spoke or made any such attempt. According to Hans Sherrer, an employee of Mornignrise Printing, "Officer Koch exploded and lost control of

himself. No one did anything to interfere with the arrest. Ms. McLaughlin was simply asking the officer by what authority he was making the arrest."

Sherrer said that officer Koch " did not read McLaughlin her rights when arrested, he did not show identification, and he did not identify her before he bodily took her away." In fact, McLaughlin said that, "Officer Koch admitted upon arriving at Orange County Jail that he did not even know if he'd arrested the right person."

McLaughlin said that she is willing to go to jail

again "if I think it's worth it."

#### LP ELECTION RESULTS

Since a political party exists with the label "Libertarian," we occasionally feel obligated to report on its activities.

One such activity of the LP which is most prominent is political elections. The LP did a better than usual job of raking in the votes. Ed Clark, a Los Angeles attorney, received around 373,000 votes for California governor (over 5.5% of the vote).

In Alaska, one LP candidate for state legislator, won with 35% of the vote. Dick Randolph, a Fairbanks insurance agent, won against six Democrats, six Republicans and one independent.

In Orange County (CA), David Bergland, running for State Senate (36th Disrict), received 14,370 votes and Jim Gallagher, running for State Assembly (73rd District), received 4,750 votes. Both received around 5 percent of the vote.

It must be stressed that the Libertarian Party is only one section of the Libertarian Movement. Other libertarians seek a multitude of approaches to bring about a freer society.

Presently, there are libertarian parties in New Zealand and Australia (called Workers Party). According to "Frontlines," a conference to start libertarian parties across Europe is scheduled for this summer in Paris, France.

## CAL LIBERTARIAN PARTY CONVENTION IN SAN JOSE

The California State Libertarian Party is having their annual convention from Feb. 16 to the 19 at the Hyatt House in San Jose. SLL will have a table at this convention.

A Libertarian Film Festival will coincide with the convention. The non-stop flim festival will include the movies, Seven Samurai, Fountainhead, Dr. Strangelove, Sometimes A Great Notion, Cool Hand Luke, Reefer Madness, The Mouse That Roared, The Fixer, Shenandoah, Serpico.

Some of the seminars and speaking programs include a keynote speech by Ed Clark, a debate on foreign policy by Prof. Tibor Machan and Roy Childs, Prof. Murray Rothbard on cpaital punishment and Bob Poole, Jr. (editor of Reason magazine) on the California Space Program. Dick Randolph, first LP candidate to win an elective post, will also appear.

#### IRS vs PRIVATE SCHOOLS


On August 22, 1978, Jerome Kurtz, U.S. Commissioner of the Internal Revenue Service issued the Proposed Internal Revenue Procedures on Private Tax-Exempt Schools. The Christian community have been up in arms ever since.

The government is now threatening to take away tax-exempt status of private sector schools if they are located within a community partaking in desegregation program. Apparently, this is the only way the government can force religious and non-religious private schools to participate in desegregation.

The IRS proposal further said that these schools are guilty of racial discrimination if they were founded after 1957, or if found earlier, they were found to have substantial enrollment increasement since desegregation programs began.

We, as libertarians, affirm: That full individual liberty is impossible in any society other than a voluntary one that agresses upon no one;

That men and women require the full and independent use of their own
judgement in order to survive at an optimum level, and therefore have a
natural right to do their own thing, providing that they do not only shelds. It
That each person owns himself or herself exclusively, and is a slave to no

That the individual is best served by society when he or she is free from the forcefully imposed controls of others, acting alone or in concert (as a

That the individual is on the controls of others, acting alone or in economic government).

That all forms of coercion and aggression are always immoral; or that the only system consistent with personal freedoms in the economic area is one that does not interfere with free trade between individuals; THEREFORE, e.e., as interfarians, resolve to oppose all forms of aggression of individuals. We further resolve to oppose taxation, conscription, eminent domain, laws which creat victimiess "crimes," and programs forced onto individuals without their consent. It is time that individual sights and coercion cannot co-exist. Liberty cannot be compromised, and we will settle for no less than freedom in our time.
